Rental Contract

Which came into life Zoltán Pércsi (1173. Bp, Újlak street 84.) in the following between Lessor and Renter. (Datas below on this paper)

The scooter can only be rented by a legal or private person who is more than 16 years old, has a permanent address, has valid personal documents and valid driving licence, furthermore has enough experience with scooter driving. The Lessor can deny the lease of the scooter if he can not be sure about the payment of the lease, or that the scooter will be used as intended.

The Renter is forbidden to lease or lend the scooter to anybody, use it on a competition or use it to prepare for a competition, tow an other vehicle with it, repair it, or make it repaired in any other workshop. Moreover it is forbidden to drive the scooter under the influence of alcohol, medicine or any other illegal drugs, or to let anybody drive the vehicle who is under the influence of the above mentioned substances.

The Lessor gives the scooter to the Renter with the actual amount of fuel and with its equipages. The Renter has to give the refueled scooter back with its equipages at the takeover's place or at the agreed place and date by the expiration of the contract. In addition the Renter has to give the vehicle back - except for the normal attrition - clean and in the same condition as it was given to the Renter. The scooter's cleaning fee is 1000 HUF. If the Renter gives the scooter back at the given time in the same condition as it was at the time of the takeover then there is no further cost and responsibility to the Renter.

The compulsory insurance is the Lessor's responsibility but it is the Renter's cost if something happens with the scooter by own or someone else's fault while the contract is valid. (harm, stealing attempt, etc.) The Renter absorbs the cost of any harm that has occured by the Renter, or if the vehicle can not be fixed, then the Renter pays the scooter's whole price which is 150.000 HUF. The Renter has to pay it in cash or through transaction if stealing or total waste occures. (total waste is when the scooter can not be fixed so it can not be rented in the future) The Lessor do not have any financial responsibility because of any harm caused by any other pearson expect of if the Lessor do not fill in the accident announcer form correctly. (On the accident announcer form the causer has to write into the note section that the whole damage is his/her responsibility)

The Renter have to request the Lessor immediately if something goes wrong while using the scooter properly. If the harm comes with financial waste then the Renter must request the police - independently of the responsibility - and show a justifying form about the matter to the Lessor. The Renter only has to pay for the replaceable components if self-caused harm occurs. The Lessor pays the costs of the repairing.

It is the Lessor's cost to fix the damage which comes from the proper use of the vehicle. The Renter must tell the Lessor immediately is any damage springs up, (For example: clatter, rattle, burnt out bulb, etc.) the Lessor must fix the damage as soon as possible - maximum 24 hours except of weekends and on holidays. Our service is free between Budapest's administrative borders, out of the borders the disembarkment fee is 3000 HUF.

The Renter must pay for any damage that came into existence because of repairing the vehicle in other repairing workshop, furthermore if the scooter goes out of order because of the Renter's inefficient behaviour the upcoming cost is have to be paid by the Renter (transportation, repairing).

The Renter guarantees that beside the time that the scooter is in use, the scooter will be stored in a safe place and takes the full financial responsibility which comes from any harm because of stealing. The Lessor does not guarantee to reimburse any harm that comes from the scooter's breakdown. Furthermore the Lessor shall not be obliged to pay back the surplus of the fuel, conversely if the Renter gives back the scooter without the right amount of fuel, then the the Renter is obliged to pay the missing amount of fuel.

A rental day consists of 24 hours which starts from the signing of the date on the contract. The Renter is obliged to bring the scooter back on the expiry day before 10:00 am, if delay occurs the Renter must pay for the delay. If the Renter still like to use the scooter, then this intetion has to be told to the Lessor in person, the latest 24 hours before the contract's expiracy. The Lessor shall not be obliged to extend the contract. In case of delay the Renter has to pay 2500 HUF per day for the late. The grace period is 60 minutes!

If the Renter presents unreal damage in connection with the scooter to the Lessor, the Renter is obliged to pay for the service a minimum 3000 HUF for the disembarkment. (for example: the scooter can not be launched because the Renter is not able to launch it, but the vehicle do not have any problem). In case of technical malfunction inside the city the disembarkment and wrecking is free of charge, out of Budapest's administrative borders the disembarkment fee is a minimum 3000 HUF. Before receiving the scooter, our repairer gives a comprehensive presentation about the use of the scooter for making the use of the scooter a great experience.

I looked through the scooter, understood the instructions, and all the points in the rental contract.
